I am fully aware that there are substantial risks to my person in the use of firearms, ammunition, indoor ranges and related products or services, and that these risks include gunshot wounds caused by myself or by another, or by ricochets, inhalation of lead vapor or other poisons, and damage to my hearing from the high sound levels, or to my vision or skin from gunshot flashes, and other dangers not listed herein.

I do hereby accept full responsibility for my own safety, I understand that I must abide by the posted rules of the range and wear eye and ear protection at all times that I am inside the range area.

I understand that if I am pregnant or believe I may be pregnant, I am not allowed on the range at any time.

I do hereby accept full responsibility for my own safety, I understand that I must abide by the posted rules of the range, and wear eye and ear protection at all times that I am inside the range area. My signature below confirm acceptance of this waiver of liability.

In the event that minor(s) accompany me, I hereby affirm that I am the parent/legal guardian of said minor(s) below the age of twenty-one (21), and further affirm that on behalf of said minor(s) I absolutely and unequivocally agree on his/her/their behalf to the conditions of release stated above.

Basic Safety Rules

- Always treat every gun as if it were loaded
- Always keep the muzzle pointed in a safe direction
- Always keep your finger off the trigger and out of the trigger guard until ready to fire
- Always put on eye and hearing protection BEFORE entering the range and wear it at all times you are in the range

Firearms may only be holstered/unholstered, cased/uncased at the firing line, with the muzzle pointed downrange. Unholstered/uncased firearms may only be carried behind the firing line to transport in and out of the range. If no holster or case is available, the action must be open, the magazine (if any) removed and the muzzle pointed in a safe direction at all times.

Safety Violations

I understand any of the following actions will cause me to be removed from the range IMMEDIATELY. I also understand removal from the premises will not be grounds for a refund on my range fee and a fee will be assessed for any range equipment damaged by my actions.

- Shooting the walls or the ceiling CUSTOMER INITIALS _____
- Pointing my gun at anyone, even unintentionally CUSTOMER INITIALS _____
- Carrying a firearm behind the safety line with the action closed CUSTOMER INITIALS _____
- Firing a black powder firearm
- Moving forward of the firing line, an action NOT permitted at any time
- Firing tracer or metal piercing ammunition

General Rules

- Leave you firearm at the position and contact the Range Safety Officer immediately if you experience any problem while on the firing line
- Clean up only your brass—Do NOT remove brass from the buckets or brass left by other shooters

Other

- Only the person(s) who has purchased range time is permitted inside the firing area—other persons wishing to observe may do so from the observation area
- While up to four (4) persons may be assigned to each lane, only one (1) person may fire or handle a firearm at the firing position at a time
- No one under 21 years of age is permitted to fire a firearm unless there is an adult on the lane with them
- Children are not permitted to roam freely about the premises—they must be supervised at all times
- Persons who appear to be under the influence of alcohol or illegal substances will not be allowed on the range
- No food or drink is allowed inside the range area
- Smoking or the consumption of alcohol or use of illegal substances is not permitted in any area of the building at any time
- Firearms on the premises are subject to inspection by a Range Safety Officer at any time—any firearm deemed “unsafe” by the Range Safety Officer will not be permitted in the range area
- Holsters used on the range must provide for muzzle forward carry and cover the firearms trigger guard—holsters that require the muzzle to point up-range during the draw are allowed
