



# WAIVER

**(Non-members must complete a WAIVER or present their WAIVER CARD on each range visit)**

I, my agents, assigns, executors or administrators, for the consideration of being allowed to enter and use the facilities, gun range and/or other products or services of Green Top Shooting Range LLC, do now hereby absolutely and unequivocally release and hold harmless Green Top Shooting Range LLC, its agents, lessor, officers, employees, instructors, assigns, owners and successors from any claim, demand, injury or liability, whether claimed by myself or another, arising out of such use of the facilities, products or services of Green Top Shooting Range LLC.

I am fully aware that there are substantial risks to my person in the use of firearms, ammunition, indoor ranges and related products or services, and that these risks include gunshot wounds caused by myself or by another, or by ricochets, inhalation of lead vapor or other poisons, and damage to my hearing from the high sound levels, or to my vision or skin from gunshot flashes, and other risks not listed herein.

**By participating in activities at Green Top Shooting Range, I understand and assume all such risks on my own behalf and on behalf of any individual accompanying me.**

I understand that if I am pregnant or believe I may be pregnant, I am not allowed on the range at any time and take full responsibility for my own safety, and the safety of any minor accompanying me.

I understand and agree to abide by the posted rules of the range, and wear eye and ear protection at all times that I am inside the range area.

I understand that persons under thirteen (13) years of age are not permitted on the range at any time. If anyone under the age of twenty-one (21) is in my party, I accept full responsibility for their actions and safety, and assume the risk of any injury caused by or to such individual. I agree to insure that such individual abides by the posted rules of the range and wear eye and ear protection at all times that they are inside the range area.

**Basic Safety Rules**

- Always treat every gun as if it were loaded
- Always keep the muzzle pointed in a safe direction
- Always keep your finger off the trigger and out of the trigger guard until ready to fire
- Always put on eye and hearing protection BEFORE entering the range and wear it at all times you are in the range

Firearms may only be holstered/unholstered, cased/uncased at the firing line, with the muzzle pointed downrange. Unholstered/uncased firearms may only be carried behind the firing line to transport in and out of the range. If no holster or case is available, the action must be open, the magazine (if any) removed and the muzzle pointed in a safe direction at all times.

**Safety Violations**

I understand any of the following actions will cause me to be removed from the range IMMEDIATELY. I also understand removal from the premises will not be grounds for a refund on my range fee and a fee will be assessed for any range equipment damaged by my actions.

- Shooting the walls or the ceiling
- Pointing any gun at anyone, including myself, even unintentionally
- Carrying a firearm behind the safety line with the action closed
- Firing a black powder firearm
- Moving forward of the firing line—doing so is NOT permitted at any time
- Firing tracer or metal piercing ammunition

**General Rules**

- Leave your firearm at the position and contact the Range Safety Officer immediately if you experience any problem while on the firing line
- Clean up only your brass—Do NOT remove brass from the buckets or brass left by other shooters

**Other**

- Only the person(s) who has purchased range time is permitted inside the firing area—other persons wishing to observe may do so from the observation area.
- While up to two (2) persons over 21 years of age may be assigned to each lane, or a parent and his or her two (2) minor children over 13, only one (1) person may fire or handle a firearm at the firing position at a time.
- No one under 21 years of age is permitted to fire a firearm unless there is an adult on the lane with them.
- Children are not permitted to roam freely about the premises—they must be supervised at all times.
- Persons who appear to be under the influence of, or impaired by, drugs, alcohol or any other substance will not be allowed on the range.
- No food or drink is allowed inside the range area.
- Smoking or the consumption of alcohol or use of illegal substances is not permitted in any area of the building at any time.
- Firearms on the premises are subject to inspection by a Range Safety Officer at any time—any firearm deemed “unsafe” by the Range Safety Officer will not be permitted in the range area.
- Only persons “Holster Certified” by Range personnel may draw and shoot from a holster.
- Only “strong side” outside-the-waistband or inside-the-waistband holsters may be used on the range. All holsters must cover the firearm’s trigger guard. No appendix holsters are permitted.
